**Sub: Last option to exercise transfer from CPF to GPF and vice versa for eligible employee of WBPDCLEWF.**

Sir,

Presently the WBPDCLEWF has both General Provident Fund (GPF) and Contributory Provident Fund (CPF) under the death cum retirement benefit (DCRB) regulation 1992. From 01.01.2012 onwards, compulsory joining in Contributory Provident Fund to cover all future recruits made applicable as per office order no. 63/2012 dated 08.02.2012.

Employees those were joined before that time i.e. 08.02.2012 were given an option to exercise for switch over in either fund on 09.01.2002. But nowhere in the option circular no.WBPDCLEWF/P&A-1/133 dt.09.01.2002 it was written that it was the last option to choose the DCRB.

**So we request you to open a last option to exercise for the eligible employees under WBPDCLEWF for switch over from CPF to GPF or vice versa.**

In this respect we also enclose herewith notification of Govt. Of West Bengal for Madrasha staff. Awaiting for your kind consideration.
